<p>5.</p>	<p>Operational update</p> <p>a) EZ investment business cases</p> <p>The EZ Board considered the business case from Alderley Park Limited (APL) for £3.87m investment in the Glasshouse project, which will see the development of 148,000 sq ft of new speculative office floorspace at Alderley Park. d) EZ site updates

Alderley Park

Sean Davies reported that demand remained strong for space at Alderley Park, but given the slower than expected withdrawal of Astra Zeneca combined with the space that CRUK has taken, they are running out of good quality available space.

Birchwood Park

Martin O'Rourke reported that they currently have no available product. Birchwood has had two recent enquires, including one for a 60,000 sq ft building. However the requirement is for existing space, rather than design and build and is unlikely to land at Birchwood. Occupier has slowed due and a number of potential occupiers appear to be holding off making investment decisions.

Hooton Park

Chris Capes reported that Redsun have launched a new brochure for Hooton Park, which they have rebranded Aviator Park. They currently promoting two large industrial units on site: a 120,000 sq ft unit and 320,000 sq ft. unit. The issues with power and surface water drainage are still in the process of being resolved.

New Bridge Road sites

Chris Capes advised there has been four investment enquiries for sites in New Bridge Road: two for speculative development and three for potential self-build projects. The opening of the new Helukabel premises on Cloister Way took place recently. Gaerwen Properties have held discussions with the LEP regarding the development of Phase 2 at Helix.

Protos

Jane Gaston reported that one of the three occupiers are close to securing the funding they need to develop on site. There have been two new enquiries, one from an Irish company and another from a Norwegian company (one a waste company, the other from the energy sector). Two recent large inward investment enquiries, ICT and Project Gamma are still in play. Work is continuing with the Grid Reinforcement project.

Thornton Science Park

Paul Vernon reported they are still awaiting the decision on the change of use planning application to cover the education uses on site. They have had an enquiry from a large German virtual reality company which would require 100k sq ft of space, creating c.400 jobs. Paul reported that it looked like Otto Fuchs might go to Deeside.

- Meetings and discussions with MSP regarding clarifications relating to the Glasshouse investment business case and appointment of Weightmans to provide legal advice and prepare draft legal agreement
- Facilitated a meeting between Lancaster University, University of Chester, Skills and Growth Company, CWAC and Warrington & Co. regarding the development of an innovation platform ERDF bid
- Meeting held with Carl Bradley from DSAP Systems regarding potential collaborations in the Science Corridor

5d) Business Rate Discount applications

The following Business Rate Discount applications have been approved by the EZ Steering Group and are recommended for ratification by the EZ Board:

- **Maxwellia** (Alderley Park) – is a company that specialises in the repurposing of patented and off-patent prescription drugs into non-prescription medicines for wider public use. For example, Nurofen used to be a prescription drug for the treatment of arthristis and is now a mass market non-prescription general painkiller, due to a process of reclassification. The company undertakes R&D to find new purposes for existing

prescription drugs and takes them through the reclassification process which includes, regulatory affairs, market research, product development, marketing, sales, education and training. The company satisfies sector test and has located from outside of the LEP area, so does not need to satisfy the growth test.

- **E M Resist** (Alderley Park) – specialises in developing materials used for electron beam lithography. The company performs research and development on semiconductor chemistry for industry and commercialises the products and manufactures them in-house for sale in the UK and Ireland and export to 15 countries around the world. The company is locating from Macclesfield and is increasing its floorspace by 20%. It also has plans to grow its FTE staff by 40% and its revenue by 22.5% over the next five years, as such the company satisfies both the sector and growth tests.
