We have received a final claim for the Blocks 22-24 project for the remaining EZ investment monies, which is currently being validated by the LEP team. The electricity upgrade at Birchwood Park (Quadrant Phase 2) is progressing slower than expected due and Patrizia are currently waiting for a final timetable for the upgrade from Electricity North West.

Item 6b: Investment pipeline

- Quadrant Phase 3 (Birchwood Park) have instructed DWF to draw up a draft grant funding agreement.
- Vortex (Newport Business Park) this scheme is considered under Item 11a.
- Alderley Park this scheme is considered under Item 11b.
- Enviroo (Protos) revised investment case received, but consideration by the Growth Corridors Board has been pushed back to January 2023 at the request of the applicant.

- Waste to Hydrogen Plant (Protos) no progress with this scheme.
- Thornton Science Park preferred development partner selected and due diligence current being undertaken.

A Senior Officers Group has been established with Department for Transport (DfT), Department for Levelling Up, Housing and Communities (DLUHC), Homes England, Infrastructure and Projects Authority (IPA), Cheshire East Council and the LEP to develop further the plans for maximising the impact of the arrival of HS2 services at Crewe. Warrington Council have appointed AECOM to undertake some high level masterplanning around Bank Quay Station.
